Right to portability of your personal data*

Note: The transfer by TIG will only take place when it is technically possible for TIG to do so

Right to object*

The processing of your personal data (including profiling) occurs (i) for the performance of a task carried out in the public interest (ii) in the exercise of official authority vested in TIG or (iii) on grounds of the legitimate interests of TIG or a third party and you wish to object to the processing of your personal data on grounds relating to your particular situation.

Please clarify what the reason(s) is/are for your objections:

Note: TIG shall no longer process your personal data unless TIG demonstrates compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise or defence of legal claims

You wish to object to the processing of your personal data for direct marketing purposes (including profiling related to such direct marketing). More specifically, you wish that:

- TIG erases all your personal data from its filing systems. TIG will contact you again in future if access is regained to your personal data from a third party
- TIG does not process your personal data anymore for direct marketing purposes and ensures that you will never receive direct marketing again from TIG or its partners

III. REACTION OF TIG TO YOUR REQUEST

TIG shall provide without undue delay and in any event within one month of receipt of your request, information on action taken on your request.

Depending on the complexity of your request and the number of requests, that period may be extended by two further months where necessary. In that case, TIG will inform you within one month of receipt of your request.

If TIG does not take action on your request, TIG will inform you within one month of receipt of your request and, in addition, TIG will provide the reasons for not taking action on your request. TIG will also inform you on the options to (i) lodge a complaint with a supervisory authority or (ii) seek a judicial remedy.

IV. PROOF OF YOUR IDENTITY

To prove your identity, you must include a copy of your identity card with this form (cfr. privacy policy)

If TIG has reasonable doubts concerning your identity, TIG may request the provision of additional information necessary to confirm your identity.
